This Report has been prepared by the Trustee of the API, Inc. Asbestos Settlement Trust ("Trust"), pursuant to Sections 2.2 (b), and (c), of the First Amended API, Inc. Asbestos Settlement Trust Agreement ("Trust Agreement"). Those sections require the Trustee to prepare and submit an Annual Report containing the Trust's financial statements, auditor's opinion, and summary of type and number of claims to the Trust during the prior year, all as more fully described in those sections of the Trust Agreement.

This Report is the Annual Report for 2009.

The Trust has retained the accounting firm of Messerli & Schadow, PLLP of Minneapolis, Minnesota, as the Trust's auditors, to prepare the Financial Statements, and to issue a fairness opinion as to those Financial Statements for 2009. Pursuant to that engagement, Messerli & Schadow, PLLP has completed both the Financial Statements, and has issued its Independent Auditor's Report regarding those Statements.

The Independent Auditor's Report, and Financial Statements are attached as Exhibit A.

The Trust has received Claims during 2009, and has made payments on Claims during 2009. In addition to new Claims paid, the Trust made a Supplemental Distribution to Claimants on November 24, 2009 pursuant to § 4.3 of the Trust Distribution Procedures. Claims received, and payments made by the Trust in 2009 are: (1) Supplemental Distribution payments made to Qualified Current Direct Claimants holding Estimated Asbestos Claims ("Estimated Asbestos Claims") pursuant to the increase in the Payment Sum Percentage, (2) Supplemental Distribution payments to previously approved, non-Estimated Claimants pursuant to an increase in the Payment Sum Percentage, and, (3) new Claims received and paid during 2009, including second injury Claims submitted and approved pursuant to §5.1(c) of the Trust Distribution Procedures.

The summary of payments made in 2009 as Supplemental Distribution payments made to holders of Estimated Asbestos Claims (1) is attached as Exhibit B.

The summary of 2009 payments made to new Claimants, and as Supplemental Distribution payments to previously approved, non-Estimated Claimants is attached as Exhibit C.

The summary of payments made to Second Injury Claimants in 2009 is attached as Exhibit D.

This Report is submitted solely for the purposes required in the Trust Agreement, and is not intended, nor should it be construed, as legal advice from the Trustee, or the Trust, to claimants, claimants' counsel, or others.

We have audited the special-purpose financial statements of API, Inc. Asbestos Settlement Trust (the Trust) for the year ended December 31, 2009 and have issued our report thereon dated March 30, 2010. Professional standards require that we provide you with the following information related to our audit.

Our Responsibility under U.S. Generally Accepted Auditing Standards

As stated in our engagement letter dated November 23, 2009, our responsibility, as described by professional standards, is to express an opinion about whether the financial statements prepared by management with your oversight are fairly presented, in all material respects, in conformity with the special-purpose basis of accounting. Our audit of the financial statements does not relieve you or management of your responsibilities.

Other Information in Documents Containing Audited Financial Statements

We understand that the Trustee includes the audited financial statements, as prepared by us, in the annual report required to be filed annually. Our responsibility for other information in documents containing the Trust's financial statements and report does not extend beyond the financial information identified in the auditor's report. We do not have an obligation to perform any procedures to corroborate other information contained in the annual report.

Planned Scope and Timing of the Audit

We performed the audit according to the planned scope and timing previously communicated to you in our letter dated November 23, 2009.

Significant Audit Findings

Qualitative Aspects of Accounting Practices

Trust management is responsible for the selection and use of appropriate accounting policies. The significant accounting policies used by API, Inc. Asbestos Settlement Trust are described in Note 2 to the financial statements. No new accounting policies were adopted and the application of existing policies was not changed during the year ended December 31, 2009. We noted no transactions entered into by the Trust during the year for which there is a lack of authoritative guidance or consensus. All significant transactions have been recognized in the proper period.

Accounting estimates are an integral part of the financial statements prepared by management and are based on management's knowledge and experience about past and current events and assumptions about future events. Certain accounting estimates are particularly sensitive because of their significance to the financial statements and because of the possibility that future events affecting them may differ significantly from those expected. The most sensitive estimate affecting the financial statements was:

Trust management's estimate of the fair market value/return of principal of the Lehman Brothers principal protected note. The estimate was based on market information available as of December 31, 2009, research regarding Securities Investors Protection Corporation, and the potential for recovery through the bankruptcy proceedings. We evaluated the key factors and assumptions used to develop the estimate in determining that it is reasonable in relation to the financial statements taken as a whole.

The disclosures in the financial statements are neutral, consistent, and clear. Certain financial statement disclosures are particularly sensitive because of their significance to the financial statement users. The most sensitive disclosures affecting the financial statements were Note 6 – Principal Protected Notes and Loss on Impairment and Note 7 – Net Claimants' Equity.

Note 6 discloses that the Trust had invested in principal protected notes and the investment bank that was the issuer of one such note declared bankruptcy in 2008. The management of the Trust estimated the amount of the impairment loss recognized during the year ended December 31, 2008 and estimated the market value of the note as of December 31, 2009.

Note 7 discloses the sources of contributions to and distributions from net claimants' equity. Net claimants' equity is the balance available to pay all claims filed with the Trust.

Difficulties Encountered in Performing the Audit

We encountered no significant difficulties in working with management in performing and completing our audit for the year ended December 31, 2009.

Corrected and Uncorrected Misstatements

Professional standards require us to accumulate all known and likely misstatements identified during the audit, other than those that are trivial, and communicate them to the appropriate level of management. The attached schedule (passed adjustments) summarizes uncorrected misstatements of the financial statements. Management has determined their effects are immaterial, both individually and in the aggregate, to the financial statements taken as a whole.

Disagreements with Management

For purposes of this letter, professional standards define a disagreement with management as a financial accounting, reporting or auditing matter, whether or not resolved to our satisfaction, that could be significant to the financial statements or the auditor's report. We are pleased to report that no such disagreements arose during the course of our audit.

Management Representations

We have requested certain representations from management that are included in the management representation letter dated March 30, 2010.

Management Consultations with Other Independent Accountants

In some cases, management may decide to consult with other accountants about auditing and accounting matters, similar to obtaining a "second opinion" on certain situations. If a consultation involves application of an accounting principle to the Trust's financial statements or a determination of the type of auditor's opinion that may be expressed on those statements, our professional standards require the consulting accountant to check with us to determine that the consultant has all the relevant facts. To our knowledge, there were no such consultations with other accountants.

Other Audit Findings or Issues

We generally discuss a variety of matters, including the application of accounting principles and auditing standards with management each year prior to retention as the Trust's auditors. However, these discussions occurred in the normal course of our professional relationship and our responses were not a condition to our retention.

This information is intended solely for the use of the advisory committee of API, Inc. Asbestos Settlement Trust and should not be used by anyone other than these specified parties.

We wish to thank the Trust and its service providers for the assistance provided us during the performance of the audit.

INDEPENDENT AUDITOR'S REPORT

We have audited the accompanying special-purpose statements of net claimants' equity of API, Inc. Asbestos Settlement Trust as of December 31, 2009 and 2008 and the related statements of changes in net claimants' equity and cash flows for the years then ended. These special-purpose financial statements are the responsibility of the Trust's management. Our responsibility is to express an opinion on these special-purpose financial statements based on our audits.

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. An audit requires that we plan and perform the audit to obtain reasonable assurance about whether the special-purpose financial statements are free of material misstatement. An audit includes examining, on a test basis, evidence supporting the amounts and disclosures in the special-purpose financial statements. An audit also includes assessing the accounting principles used and significant estimates made by management, as well as evaluating the overall financial statement presentation. We believe that our audits provide a reasonable basis for our opinion.

As described in Note 2, these special-purpose financial statements were prepared on a special-purpose basis of accounting and are not intended to be a presentation in conformity with accounting principles generally accepted in the United States of America. The special-purpose basis of accounting has been used in order to present the amount of equity available to current and future claimants.

In our opinion, the financial statements referred to above present fairly, in all material respects, net claimants' equity of API, Inc. Asbestos Settlement Trust as of December 31, 2009 and 2008 and the related changes in net claimants' equity and cash flows for the years then ended, in conformity with the special-purpose method of accounting described in Note 2.

NOTE 1 DESCRIPTION OF THE TRUST

The API, Inc. Asbestos Settlement Trust (the Trust), organized pursuant to the laws of the State of Minnesota, was established according to the Third Amended Plan of Reorganization of API, Inc. as modified (the Plan). The Trust was formed to assume all asbestos claims against API. Inc., whether now existing or arising at any time hereafter, and to use the Trust's assets and income to pay holders of allowed asbestos claims in accordance with the Plan and Trust Agreement. The Trust's funding is dedicated solely to the settlement of asbestos health claims and the related costs, as defined in the Plan. The Trust was consummated on February 5, 2007.

The Trust was initially funded with cash, a promissory note from API, Inc., rights to proceeds from asbestos insurance policies and insurance settlement rights.

NOTE 2. SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

The Trust's financial statements are prepared using special-purpose accounting methods that differ from accounting principles generally accepted in the United States of America. The special-purpose accounting methods were adopted in order to present the amount of equity available for payment of current and future claims. Since the accompanying special-purpose financial statements are not based on accounting principles generally accepted in the United States of America, accounting treatment by other parties for these same transactions may differ as to timing and amounts. These special-purpose accounting methods are as follows:

- (1) The financial statements are prepared using the accrual basis of accounting.
- (2) The funding received from API, Inc., API Group, Inc. and the insurance companies are added directly to net claimants' equity and the distributions to claimants are deducted directly from net claimants' equity. These funds do not represent income or expenses of the Trust.
- (3) Non-interest bearing notes have not been discounted to present value.
- (4) Costs of non-income producing assets, which will be exhausted during the life of the Trust and are not available for satisfying claims, are expensed as they are incurred. These items include costs of computer hardware, software and insurance premiums.

NOTE 2. SIGNIFICANT ACCOUNTING POLICIES (continued)

Basis of Presentation (continued)

- (5) Investments are recorded at fair market value. All interest and dividend income is included in interest and dividend income on the statements of changes in net claimants' equity. Realized and unrealized gains and losses are reflected on the statements of changes in net claimants' equity.
- (6) The Trust does not record a deferred tax asset for net operating loss carryforwards or a deferred tax asset or liability arising from unrealized gains or losses on securities. For the years ended December 31, 2009 and 2008, the net operating loss carryforward available for use in future years was \$3,230,958 and \$3,100,657, respectively.

Cash and Cash Equivalents

The Trust considers unrestricted currency, demand deposits, money market accounts, and certificates of deposit with an initial maturity of three months or less to be cash and cash equivalents.

Fixed Assets

The cost of non-income producing assets that will be exhausted during the life of the Trust and are not available for satisfying claims are expensed as incurred. Since inception of the Trust through December 31, 2009, the cost of fixed assets expensed includes website development costs of \$4,003.

Claims Payable

Claims payable on the statements of net claimants' equity reflect claims approved but unpaid as of December 31 of each year.

Estimates

The preparation of financial statements in conformity with the special-purpose accounting methods described above requires Trust management to make estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions to net claimants' equity during the reporting periods. Accordingly, actual results may differ from those estimates.

Subsequent Events

In preparing these financial statements, the Trust has evaluated events and transactions for potential recognition or disclosure through March 30, 2010, the date the financial statements were available to be issued.

NOTE 3. NOTE RECEIVABLE

Note receivable as of December 31, 2009 and 2008 consisted of a promissory note from API, Inc. The original face value of the note was \$26,000,000. The note calls for eighty quarterly payments of \$325,000 and is due in full in March 2027. The note bears no interest. The note is secured by 51 percent of the common shares of API, Inc. and certain other assets of API, Inc. As of December 31, 2009, the note was receivable as follows:

NOTE 4. INSURANCE SETTLEMENTS RECEIVABLE

In January 2008, settlement agreements were approved by the courts with seven insurance companies. The initial gross cash settlement amounts were \$60,500,000 plus interest, net of legal fees related to the settlements. The insurance settlements were received during the year ended December 31, 2008.

Pursuant to the settlement agreement with one of the insurance companies, the immediate cash settlement of seven million dollars was paid to the Trust by February 10, 2008 and was nonrefundable. The remainder of the aggregate settlement amount is payable to the Trust upon certain criteria being met. Upon such time that the insurance company reimbursement obligation for all qualified asbestos claims related to the insurance carrier exceeds the original cash settlement amount of seven million dollars, the insurance carrier is obligated to make additional settlement payments to the Trust, up to a maximum of an additional eleven million dollars. As of December 31, 2009, the reimbursement obligation for the insurance carrier had not exceeded the original cash settlement amount. The amount of the potential additional settlement funds is undeterminable at this time and has not been reflected in the financial statements.

NOTE 5. INVESTMENTS

Investment securities are recorded at market value as measured by quoted prices in an active market. Unrealized gains on investments were \$554,545 for the year ended December 31, 2009; unrealized losses were \$69,904 for the year ended December 31, 2008. Realized gain on sale of investments was \$176,026 and \$17,546 for the years ended December 31, 2009 and 2008, respectively.

Investment income, consisting of interest and dividend income, was \$668,192 and \$690,833 for the years ended December 31, 2009 and 2008, respectively.

NOTE 6. PRINCIPAL PROTECTED NOTES AND LOSS ON IMPAIRMENT

During the year ended December 31, 2008, the Trust invested in four principal protected notes issued by three different investment banks. The notes, each \$1,000,000, called for the return of the principal amount of the investment and potentially earnings if certain criteria were met. The earnings potential was tied to specified indices falling within a predetermined range at the maturity of the notes. The notes were reported at cost in the statements of net claimants' equity. The notes matured during the year ended December 31, 2009. For three of the principal protected notes, the Trust received a return of the original principal of \$3,000,000 without earnings, as the specified indices range was not met.

During the year ended December 31, 2008, one of the investment banks for which the Trust held a principal protected note declared bankruptcy. The Trust filed a proof of claim with the bankruptcy court. The amount of the recovery as a result of bankruptcy proceedings is undeterminable at this time. The original cost basis of the principal protected note was \$1,000,000. Trust management estimated the recoverable amount of the note to be \$500,000. This is based on management's belief that the investment is covered by the Securities Investor Protection Corporation and the assumption that the Trust will recover a portion of the investment in the bankruptcy proceedings.

For the year ended December 31, 2008, an impairment loss was recorded for the investment and the cost basis was reduced to reflect the estimated impaired value. The \$500,000 loss on investment impairment is reflected on the statements of changes in net claimants' equity for the year ended December 31, 2008.

NOTE 7. NET CLAIMANTS' EQUITY

The distributions to claimants represent a payment sum percentage of 55 percent and 50 percent of the allowed liquidated value per claimant as of December 31, 2009 and 2008, respectively, per the Trust Distribution Procedures. The Trust Distribution Procedures allow this percentage to be evaluated at least once per year by the Trustee, the Legal Representative and the Trust Advisor. The distributions also include enhanced payments for exigent health, extraordinary or extreme hardship claims as determined by the Trustee.

NOTE 8. INCOME TAXES

For federal income tax purposes, API, Inc. has elected for the qualified assets of the Trust to be taxed as a Designated Settlement Fund (DSF). Income and expenses associated with the DSF are taxed in accordance with Section 468B of the Internal Revenue Code. The federal statutory income tax rate for the DSF is 35%.

The Advisory Committee believes the Trust is operating in a manner so as to continue to qualify as a Designated Settlement Fund. The Trust recognizes potential interest and penalties pertaining to income tax related issues, if any, as income tax expense. During the years ended December 31, 2009 and 2008, no such interest or penalties were recognized.

The Trust Advisory Committee evaluates all tax positions and makes a determination regarding their likelihood of being upheld under review. For the years ended December 31, 2009 and 2008, the Trust did not have uncertain tax positions for which they recorded a tax liability.

NOTE 9. RELATED PARTY TRANSACTIONS

During the years ended December 31, 2009 and 2008, the Trust incurred fees of \$336,673 and \$358,611, respectively, from members of the advisory committee in their roles as trustee, legal representative and trust advisor. Of these amounts, \$28,144 and \$19,479 are included in accounts payable on the statements of net claimants' equity as of December 31, 2009 and 2008, respectively. The trust advisor is a principal member of the law firm representing numerous claimants.

During the year ended December 31, 2009, the Trust incurred fees of \$4,000 for professional services provided by a member of the Trustee's family. This amount is included in professional services for the year ended December 31, 2009 on the statements of changes in net claimants' equity.

NOTE 10. CONCENTRATIONS AND CREDIT RISK

The Trust had significant concentrations of credit risk as a result of maintaining its bank accounts with aggregate balances in excess of federal insurance coverage. As of December 31, 2009 and 2008, the maximum loss that would have resulted from that risk was \$163,919 and \$39,129, respectively, which represents the excess of bank deposits over the amount that would have been covered by federal insurance.

The Trust invests in professionally managed portfolios. Such investments are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the Trust's investment account balances and the amounts reported in the special-purpose statements of net claimants' equity and statements of changes in net claimants' equity.
